- 4. The corporation is organized for the following purpose:

Providing financial support to elderly persons, homeless and orphans in India particularly to the House of Mary and Joseph who will provide helpful services to the above named classes of persons.

- 5. The corporation shall not have members. The members and classes thereof, if any, shall have their qualifications, rights and limitations set forth in the bylaws or attached hereto.
- 6. Directors shall be elected as set forth in the bylaws.
- 7. Provisions Relating to Tax-Exempt Status:

a. Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose and shall be distributed, in all details to ensure this corporation's eligibility for 501(c)(3) status. ¹

b. restriction on activities (required for tax exempt status)

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Fourth hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf

of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under $\underline{\text{section } 501(c)(3)}$ of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under $\underline{\text{section } 170(c)(2)}$ of the Internal Revenue Code, or corresponding section of any future federal tax code.

- 8. The rights and limitations of the different classes of members shall be set forth in the bylaws.
- 9. The first Board of Trustees(s) shall consist of *five* Directors. (minimum of three) ²
